Unnecessary Delays



CVVOA - 8/21/2016

- Rule changed in 2015
 (No longer results in a charged time-out hands on hips no longer used)
- Any action by team/member that causes delay to start/resumption of play
- Coach is <u>not</u> required to sit
 (Rules 9-9-1 Penalties 1, 2 and 12-2-6 Note 2)
- Unnecessary delay does <u>not</u> carry over to next set
- Repeated violations in multiple sets <u>could</u> become unsporting conduct (if on coach/bench, then head coach would be required to sit)

- Mechanics Administrative card procedure
 - Administered by R1/R2 that initiates the call
 - Card on wrist (whistle, signal 22)
 - 1st offense warning (Yellow card on wrist)
 - 2nd offense penalty (Red card on wrist) for subsequent offense(s) by same team in same set (loss of rally/point)
 - Illegal substitution (whistle, signal 20 then 22)
 (Hand circled above head, then card on wrist)
 - R2 ensures Scorer records in comment section
 YUD/RUD, Team/Individual, Score (offending team first)

- 14 reasons for unnecessary delay
- Illegal player equipment/uniform (Rule 4)
 - Player with jewelry / illegal equipment
 - Attempts to enter / discovered in set
 - Unnecessary delay warning/penalty
 - TO allowed for player to make legal
- Improper substitution or libero procedure
 - Still use preventive officiating
 - Repeated offenses can result in unnecessary delay

- Illegal sub/replacement attempting to enter set
- Delay returning from TO (could be clean-up of liquid/substance)
- 3rd TO requested
- Improper request
 - Sub / TO / Line up request(R2 whistles after R1 whistled/beckons for serve)

- Illegal libero replacement
 - Libero may only be replaced by player they replaced (Libero in for #22, but #9 replaces libero)
 - Libero replacement does not occur behind the attack line and in front of the end line

(Reminder – preventive officiating)

 Multiple libero replacements during the same dead ball/end of rally

(Unless libero replaces right back player and can legally serve the next rally – libero could come from any back row position)

Libero replacement during a TO

(Six players on court prior to TO must all return, then a libero replacement can occur)

Libero not listed on lineup card or roster

Rule 10-4 - Libero Replacements

- Illegal libero replacement
 - Officials detect prior to first whistle/beckon to serve
 - Detected by R1/R2 (Fantastic!)
 - Libero Tracker detects
 (LT should immediately notify R2 R2 should brief LT to that effect)
 - Unnecessary delay used to address situation
 - If warning (yellow card), serving team still retains serve
 - If penalty (red card), loss of rally/point
 - Officials detect after first whistle/beckon to serve
 - Illegal alignment fault

(Loss of rally/point)

- Receiving team fault, point for serving team
- Serving team fault, loss of rally and point for opposing team
- In all cases, the illegal replacement must be replaced by a legal player

Rule 10-4 – Libero Replacements

- Illegal libero replacement
 - Detected after multiple whistles/beckons to serve (Still illegal alignment fault)
 - For serving team, any points known to have been scored following illegal libero replacement are canceled (Rule 10-4 Penalty 2)
 - For receiving team, prior to the contact of serve by the opposing team, all points earned during the previous term of service following illegal replacement shall be canceled (Rule 10-4 Penalty 3)
 - After the serve has alternated and the first serve is contacted, there shall be no cancellation of points (Rule 10-4 Penalty 4)
